Szettella suggested that we change that to \$240/year for the Alumni Association.</li> <li>We would allow the new alumni to have reduced financial responsibility (1/2 price for two years after leaving the active chapter in good standing).</li> <li>Dues would be divided: 25% to housing corp, 25% to scholarship, 50% to Alumni Association to ensure funds for events, insurance, etc. – No official motion brought to the floor.</li> </ul>
